

JENSEN & PILEGARD CONSUMER CREDIT APPLICATION
ACCOUNT AGREEMENT

I. OPEN ACCOUNTS. All bills are due and payable on the 10th of the month following date of purchase. A PAST DUE CHARGE at the ANNUAL PERCENTAGE RATE of 18% (1 ½% per month) will be added to all past due accounts (subject to a \$1.00 minimum). This is not an agreement to give further time for payment.

II. INSTALLMENT ACCOUNTS. BUYER agrees to pay the "TOTAL OF PAYMENTS" in monthly installments with amount, number of payments and payment due date specified by Security Agreement. A FINANCE CHARGE at the Maximum Rate pursuant to Civil Code Sec. 1805 is included in the TOTAL OF PAYMENTS, subject to a \$15.00 minimum FINANCE CHARGE.

III. OPTIONAL PAYMENT PLAN – INSTALLMENT ACCOUNTS. Buyer may pay the AMOUNT FINANCED in three monthly installments as specified by the Security Agreement Sales Contract. There will be no FINANCE CHARGE if payments are made as specified. Should BUYER not use OPTIONAL PAYMENT PLAN, the terms of the INSTALLMENT ACCOUNT outlined in item II automatically apply.
